- I.** Roll Call
 - a. Van Cleve called the meeting to order at 6:00pm.
 - b. Granaas called roll; Gruntner, Sharma, and Narayan were absent.
- II.** For Action: Approve Agenda
 - a. Govada motioned to approve the agenda; second by Showalter.
 - b. Motion carried.
- III.** President's Remarks
 - a. Welcome to another great year of MCSA! Last week new President Kahler was here and we did a great job of portraying ourselves as a fabulous campus. Last weekend was the MCSA-Sponsored Amazing Race and we had a great turnout.
 - b. Please be checking your emails because your committee chairs will be emailing you to coordinate upcoming meetings and schedules.

- IV.** For Information: Brief Review of Robert's Rules
 - a. Van Cleve must call on you before you are allowed to speak in Forum.
 - b. Actions are opened to discussion and a vote through a motion that is seconded.
 - c. Amending a motion that's on the floor needs its own motion and its own second. Then the amendment gets voted on before the original motion gets voted upon.
 - d. You may not speak twice if people still have not spoken once.
 - e. To ask a question, you may raise your hand and ask "Point of Information." Forum moves quickly; don't be intimidated by asking for information.
 - f. Most actions require a majority vote to pass. A 2/3 vote is required for Calling the Question (ending the discussion and moving immediately to a vote).
 - g. Showalter asked about the precedence system.
 - i. Postponing a motion, called Tabling, will allow the motion to be voted upon at a later time.
- V.** For Information: Attendance Policy
 - a. You need a valid excuse to miss a meeting of any kind because your attendance is mandatory. Please don't leave early or arrive late. If unavoidable situations arise, let Van Cleve know in advance by sending an email or finding him in person.
- VI.** For Information: Ranking Member System
 - a. Ranking members in your committee are responsible for your attendance; please let them know if you will be absent from a committee meeting.
 - b. Ranking members will be responsible for submitting a committee report to Van Cleve the same week your committee meets.

 - a. Govada motioned to open nominations for the Fall Retreat Committee; second by Showalter.
 - i. Fall Retreat will tentatively be on September 18.
 - ii. Showalter, Forde, and McBrady nominated themselves to be part of the Committee.
