## FALL SPOTLIGHT

### Parent/Guest Access

Expecting help from a parent/guest in the future?

Students may grant access to parents/guests to view select information or make a payment on the student's account. Some common examples for this access is to allow the parent/guest to:

- View bill
- Make a payment
- View grades
- View financial aid
- View class schedule

Once established, parents/guests can access their student's information through MyU.

## PLANNING FOR FALL

- **Health insurance:** Degree-seeking students registered for 6+ credits must have health insurance. Students can enroll in the University-sponsored Student Health Benefit Plan for \$1,272/sem. or waive the University's coverage in MyU by October 1st.
- **Billing/payment information:** Payment is due in full Sep. 4th unless the student enrolls in the payment plan for a \$20 fee. Balances must be paid before a student can register for the next term.
- **Financial aid:** Be sure to check your financial aid checklist in the My Finances tab to ensure you've submitted all necessary information.
- **Emergency grant:** The SAGE grant can be used to provide quick-response funding to students for short-term financial emergencies. Read more at [z.umn.edu/ummgrantswaivers](https://z.umn.edu/ummgrantswaivers).
- **Loans:** First time taking out a federal loan? You will need to complete Entrance Counseling and a Master Promissory Note at [studentaid.gov](https://studentaid.gov) before your loans can disburse.
