**I. MINUTES**

Josh made a motion to approve the minutes of the April 12, 2012, meeting, with a spelling correction. Cheryl seconded. Motion was approved (5-0-0)

**II. Summary of University of Minnesota Morris Student Living on Campus**

TJ Ross presented to the committee information on the mix of students living on campus as opposed to living off campus. UMM is slowly increasing the percentage of students on campus from 44% in Fall of 2007 to 49% in Fall of 2011. UMM has no requirement for students to live on campus, however, living on campus is highly encouraged as residential living enhances the liberal arts college experience. It was noted that 95% of our first year students choose to live on campus. Each year approximately 40% of the students living on campus choose to return to on-campus housing.

**III. Student Center Committee Report 2012**

The committee reviewed the report from the Student Center Committee from their meeting during Spring Semester of 2012, where they prioritized a list of renovation plans/major purchases for the Student Center.
