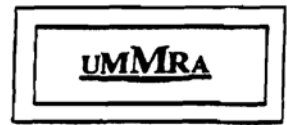
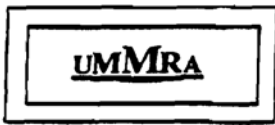

UMMRA 2012-2013 IN REVIEW

The UMMRA Board plans UMMRA programs and agendas for the year, including the quarterly meetings, picnics at the beginning and end of the year, First Thursday luncheons, and the reception at the LaFave House prior to the annual recognition dinner. The Board oversees membership, membership benefits, the budget, and the award of mini-grants, and it addresses specific issues as they arise.

This year’s UMMRA quarterly business luncheons were held on October 4 and February 7 in the Gazebo Room at the Prairie Inn and on April 4 in the Prairie Inn’s Cougar Room. Meetings began at 11:45 a.m. We scheduled speakers at these meetings in addition to social interaction. Morris Officer Ross Tiegls talked about “Identity Theft and Scams.” UMM senior Naomi Wentz reported on the enrichment internships in which she has been involved during her years at UMM. Of special interest was her research on sanitation problems in Cambodia and the activities she since has initiated to raise funds for purchasing toilets for the area in Cambodia she visited. In April Chancellor Johnson provided us with an update of happenings at UMM. [See *UMM News* on the right.]

UMMRA members also got together for First Thursday lunches during most months when other UMMRA events were not scheduled. The opening fall potluck was held in the West Central Horticulture Gardens in September with Steve Poppe describing different plantings. Deb Nelson spoke about the Lakeland Hospice in November. A holiday party took place at the Prairie Inn on December 6. We attended a choral concert on campus together in March and held a reception for faculty and staff at the LaFave House before the Recognition Dinner. Rande Hokanson, Stevens County Historical Museum, is scheduled to speak at the June potluck picnic.

The by-laws were amended by the membership. The single Secretary-Treasurer position was changed to become two positions, secretary and treasurer, because of the increased amount of work in those roles. The webmaster was added as an ex-officio board position. The Board oversaw the UMMRA website, the *UMMRA Info* newsletter, and proposed making the Newsletter available electronically beginning next fall to those who want to receive it that way. UMMRA volunteers read to residents

at West Wind Village and contributed to campus events. UMMRA will donate to the UMM General Scholarship Fund in memory of UMMRA members who died during the academic year. UMMRA has 118 members and a bank balance of \$2991.51.

- The 27th Annual French Poetry Contest, named in honor of **Edith Farrell**, was held on Tuesday, April 2, in Oyate.
- **Harold and Elizabeth Hinds** plan to move to Portland, OR in June to be near their families.
- **Gail Hockert’s** retirement on May 20, 2013 was announced recently.
- **The Jooinn Lee Lecture**, scheduled in March, was postponed twice because of snow. It will be given in fall at a time to be announced.
- **Sam and Nancy Schuman** recently returned from Argentina and will attend the International Nabokov Association meeting in Paris in June.
- **Bonnie Tipcke** and her family invited the campus to join them at Old #1 on April 19 to celebrate her retirement
- A group of admirers of **Jim Togeas** interrupted his last class to say a few words of thanks for his over 7000 lectures and 50+ years at UMM. Jim will continue to teach honors courses during his retirement.
- A concert by the Symphonic Winds dedicated to the memory of **Ralph Williams**, who died on February 2, was performed on April 21 in the HFA Recital Hall. J. Wesley Flinn’s “Plains and Pines, a fantasia based on [Ralph’s] UMM Hymn,” had its first performance.

UMM NEWS

● **The HFA Gallery** has been named in honor of Edward J. and Helen Jane Morrison in recognition of seven decades of generous support for UMM and their recent philanthropic commitment to the renovation and endowment of the gallery. Ed was owner and publisher of the *Morris Sun and Morris Tribune* for many years. Helen Jane established the first concert series which grew into the Performing Arts Series. Thank you, Ed and Helen Jane.

● **Chancellor Johnson** reported to the campus community that applications from new high school students and offers of admission are at a thirteen-year high. Retention of first year students also “looks very positive.” She is “cautiously optimistic,” since applications and offers are only reasonably good predictors of enrollment.

● Though the snow kept coming, progress was made in completing much work on the inside of the new dormitory, “Green Prairie Hall.”

● **UMM’s 50th Commencement** was held in the P.E. Center on May 11 with nearly 350 seniors graduating. U.S. Senator Al Franken gave the commencement address. This year’s Commencement also was streamed on-line.

● **UMM** has again been included in [The Princeton Review's Guide to 322 Green Colleges](#) based on a 2012 survey of administrators at over 800 four-year colleges. The *Review* commends Morris for its “deep roots in agriculture and land stewardship.”

This is a call to join or renew membership in the UMM Retirees Association (UMMRA) for the 2013-2014 fiscal year. If you are still on the staff or have previously been so, you are eligible to join your colleagues and fellow staffers in UMMRA. Our membership consists of both retired and not-yet-retired members of any University of Minnesota unit, primarily those units in the Morris area, i.e., WCROC, Minnesota Extension, Continuing Education, etc., as well as UMM. Membership includes faculty and all other staff (including bargaining units) and spouses. At present we have 118 members.

UMMRA functions not only as a social organization where members occasionally meet with old friends, but also helps members make the transition to retirement a bit easier. Members receive our newsletters and communications, such as e-mail, about special lectures, events, or activities both on campus and in the community, as well as those sponsored by UMMRA.

We offer retired members certain benefits, such as free UMM parking permits, and information on their "perks" as University retirees, such as how to be maintained in the University data base (at present this is not automatic), and how to obtain a retiree "U-card" for continued access to libraries and other University facilities. We serve as a link to the administration, and are continually defining and trying to upgrade benefits for retirees. We also provide mini-grants up to \$350 to members who want to pursue special interest projects. UMMRA also has a representative on the all-University Retirees Association Board in Minneapolis (UMRA).

We hope that you will join UMMRA for the 2013-2014 season. During your first year of retirement, your dues are waived, but you still need to return the form below.
