I. Minutes

Holly made a motion to approve the minutes of the December 5, 2012, meeting, Sheila seconded. Motion was approved (8-0-0).

II. UMM Students List Policy

The committee reviewed the opt in revision to “ummstudents” e-mail list. Sheila made a motion to approve the revision, Barry seconded. Motion was approved (8-0-0).

III. Paper Cut Printers in Residence Halls

Tamir informed the committee of a survey that had been sent to students for their thoughts on the addition of paper cut printers in the residence halls. There were approximately 203 responses from students, and indicated the additional printers would be appreciated. Holly made a motion to endorse the placement of printers in the residence halls and recommended requesting tech fee funding for the project, Cory seconded. Motion was approved (8-0-0).

IV. Baby Changing Tables

The committee was told that the Commission on Women would endorse the proposal for the phasing in of baby changing tables if the PE Center Mezzanine is added to Phase 1. Sheila made a motion to add the PE Center Mezzanine to Phase 1 of the proposal, Holly seconded. Motion was approved (8-0-0).

Sandy provided some background information on the Educational Benchmarking Inventory for the committee in regards to on-campus/off-campus housing ratios.

VI. Student Organizations

The new student organizations, SOS Brigade, Classics Club, Journal Club, and Intercultural Connections and Communication Club were reviewed, as well as a minor change to the audition procedures for Dance Ensemble. Holly made a motion to approve the new student organizations and the constitutional change, Cory seconded. Motion was approved (8-0-0).
