ARFC Minutes 12-6-18

- I. Welcome
 - A. Meeting called to order at 6:31pm
- II. Approve Minutes from 11-1-18

- IV. Classify Requests
 - A. **Sigma Delta Pi:** Looking for funds to have an initiation for new members. Parker moves to classify as an E, Ariel seconds. Motion passed.
 - B. **Alpine Club:** Looking for funds to go on a skiing trip. Ariel moves to classify as a C, Andre seconded. Motion is withdrawn and Ariel makes a new motion to classify as a C2. Parker seconds and motion is passed.
 - C. **College Republicans:** Looking for funds to print posters and to hold a recap meeting. Andre motions to classify recap meeting fund as a B, Connor seconds. Motion is passed.
 - D. **Intervarsity:** Looking for funds for projects assistance. Andre moves to classify as a C, Ariel seconded. Motion passed.
 - E. **Fishing Club:** Looking for funds for a fishing trip. Andre motions to classify as a C2, Parker seconds. Connor moves to amend to D2, amendment is accepted. Motion is passed.
- V. Hearings
 - A. **Sigma Delta Pi (6:45)**
 1. Initiation for new members for the national organization. Open to all spanish students with a certain GPA. 25 people will be at the event so total cost would be \$250. Current balance will go towards spring activities. Ariel moves to fund at \$250, Andre seconds. Motion is passed.
 - B. **Alpine Club (7:00)**
 1. Looking for \$1,667.00 for multiple ski trips during the winter months. Fund would cover travel costs, lift tickets, and winter gear. Over 20 students have shown interest to go on the 7 planned trips. Ariel moves to fund at \$800, Brianna seconds. Parker makes an amendment to \$725, amendment is accepted. Motion is passed.
 - C. **College Republicans (7:15)**
 1. Recap meeting to go over everything that happened this semester and what's going on next semester. Funding will go towards food based on the turnout for the midterm election meeting. Current funds will be paying for the midterm meeting. Connor motions to fund at \$88, Autumn seconds. Ariel amends to \$87, amendment not accepted. Motion for \$88 passed. The printing of posters will be for advertising of weekly meetings.

Posters would be changed monthly and 10-15 posters will be printed. Ariel moves to fund at \$49, Andre seconds. Motion failed. Connor moves to fund at \$50, Sam seconds, and Ariel amends to \$51. The amendment is accepted. Parker amends to \$50 and that amendment is accepted. Motion for \$50 is passed.

D. InterVarsity (7:30)

1. General request to help with fundraising supplies, poster printing, and weekly expenses. 50 students come to meetings and members are paying out of pocket for meeting-related supplies. The fund will help keep everything professional and successful. Parker moves to motion at \$367.00, Ariel seconds. Motion is passed.

E. Fishing Club

1. Andre closes the door at 7:41. Looking for funds for ice fishing supplies for those who are interested and don't have any as well as tournament entry fees. Supplies include bait, poles, heaters, and augers. Ariel moves to fund at \$750, Autumn seconds. Amendment to \$500 is accepted. Autumn amends to \$600, amendment not accepted. Proposal to \$600, Connor seconds. Ariel withdraws \$500 motion. Ariel motions to fund at \$600, Andre seconds. Motion is passed.
