- VII. Hearings
 - A. **Role Playing Game Club (7:00)**
 1. Looking for funds of \$590 for an all-night roleplay event held in Humanities November 1st-2nd. Expecting 70 plus individuals at the event. Food would include: pizza, fruit, and coffee. Discussion. Ariel moves to fund in full. Brandon seconds. Discussion. Motion passed.
 - B. **College Republicans (7:10)**
 1. Looking for funds of \$3,136 to go to the 2020 CPAC conference. Funds would go towards hotel (2 rooms, 3 nights), car-related travel. There is money in account that is going towards total expenses for this trip. Discussion. Members are contributing \$250 already to go on the trip. Fundraising comes from Pizza Ranch Tip Night.  - C. **Morris Ping Pong Club (7:20)**
