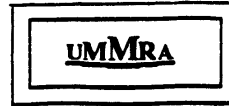

My First Year at UMM

I had been a stay-at-home Mom for the first 14 years of our marriage with four children and living on a dairy farm near Hancock, MN. After a severe hail storm in July of 1965 we decided one of us had to find employment. So I answered an ad in the Morris paper. I did not hear anything until one rainy day in September when Karl Bronhofs, the business manager, called me to the University. He wondered if I could handle a job with four children at home and I had to promise to stay for two years. It was an exciting time for our family and the beginning of a long-time employment for me. The Business Office was located in Edson Hall and had five people including Lois Norby and Martha Eul who helped break me in. Others I remember were Karen Carlson and Ann McKay, the cashier. We soon moved over to the remodeled second floor of Behmler Hall where I spent the next 30 years. I was a secretarial assistant doing a lot of typing invoices and preparing documents—all done by hand and with carbon copies. Martha Eul left that December and I moved into her job as a secretary. I handled accounts payable and purchase orders, did lots of record keeping and telling companies when their "check was in the mail". I remember coffee breaks with Ann Webster, Thelma Gilbert, Mavis Drange and Herb Croom. So my first year was busy and full of challenges. I always stayed in the Business Office and those people were my "family" away from home. I retired in December, 1995 after 30+ years. So UMM has been a big part of my life and I wouldn't trade it for anything.
