HISTORY OF UMMRA

MEMORY TOURS OF UMM

This is a new addition to the UMMRA INFO newsletter. It will contain memories of faculty and staff of their first year at UMM. We will start with Barbara McGinnis, edited for space reasons with her approval. The unedited writings will be kept in the archive file in a special folder

"We came to Morris on a very hot July in 1961 and the only house for rent was a tiny two-bedroom on West Tenth Street. Pat finally found a house in the country that the owner used for his daughter's family when they came to spend the summer. After two weeks in the tiny house, some of the '61 faculty members (Don Spring, Nat Hart, Jack Imholte, Jim Gremmels, etc.) moved us out to the farm. Pat and Nat had been office mates in Minneapolis. Pat was to teach 17th century literature. His first office was on second floor of Social Science with a fine viewing of the countryside. Our fourth child was born on September 14 and Don Spring took me to the hospital because Pat was in Minneapolis for a meeting. Son, Colin, was shown off to the faculty at our first party, an Oktoberfest with lots of beer, wine and German food. Heretofore, the parties had BYOB but we weren't aware of that. The sheep on the farm kept the grass looking like a park, trimming the grass and eating the trees as far as they could reach. With spotlights in the trees, it was quite lovely. We bought a house on East Fifth Street in March of 1962. To move us the snowplows opened the farm road to bring in two trucks, then plowed it again so they could get out. Pat found UMM a wonderfully exciting place to teach. To be on the founding and growth of a new college of the University of Minnesota made the long faculty meetings and difficult decisions worthwhile. He was diagnosed with leukemia in the summer of 1964 and finally was granted his Ph.D. degree in June of 1966. Pat died that August leaving Catherine 9, Clare 8, Mara 6, Colin 4 and Tim 3."
