In these minutes: Continued review of draft poster procedures and MCSA forum feedback

Meeting was called to order at 11:40am. Bryan Nell made a motion to approve the minutes from 2/25/2020 as amended and seconded by Viktor Berberi. All members approved.

Autumn provided feedback from the MCSA forum where the Poster Procedure Practices draft was presented. There were not any overall objections to the draft and students mainly asked clarifying questions. Some of the student feedback included:

- location of the bulletin board in the Cube (for apartment residents) is upstairs and not seen often as students primarily use laundry in basement
- Students feel only one board in the resident halls is not enough
- recommend that each poster has disability line on it as well as contact information.
- clarification on chalking policies – CA's are able to chalk and it is considered a University Department

Additional meetings are occurring this week to receive feedback on the draft poster procedures from various groups.

The committee reviewed current process for obtaining a group/individual contact information as well as pros and cons for requiring this information on all posters or only on University postings not on general posters. Currently contact information is kept by Student Activities.

Recipient Award for Edson Award was determined by the subcommittee and submitted.

Discussion of possible topics for future meetings included inviting the Curriculum/High Impact learning Committee to discuss proposals.
