It provides for the enforcement of procedures and regulations to maintain appropriate standards of conduct within the student community. - C) Review of 2019-2020 Committee Work
 - Summary of Activities:
 - Approved the constitutions of several new student organizations and along with revisions to the constitutions of existing organizations.
 - Discussed revision of the Student Organization Classification Policy for the Morris campus.
 - Endorsed revisions to the policy for Partisan Student Group Funding. New policy now reads:

Partisan political student groups are not eligible to apply for and/or receive general student services fees. "Partisan political student groups" are organizations affiliated with and in support of a registered political party or candidates for election. Such groups may seek funding for their nonpartisan political activities (e.g. candidate forums available to all qualified candidates, nonpartisan education programs, etc.) through other University grant and student funding programs.

No registered student group may use University funds for partisan activity (defined as any activity in support of a registered political party) or on behalf of a candidate for public office in a political campaign.

- Approved members for Student Behavior Committee.
- Reviewed and gave feedback on the Proposed Campus Inclusivity Initiatives.
- Produced a draft revision to the campus-specific Posting Policies. Considered feedback from various bodies, including: Consultative Committee, Equity and Diversity Committee, MCSA, COWGE, and MaryElizabeth Bezanson and 4th-year Political Science student James Sukanen.
- Chose the recipient of the Allen W. Edson Award.
- D) Discussion of possible agenda Items for the semester / year
 - a. Continuing to work on food insecurity
 - b. We may want to get involved with the Morris Mission
 - c. Posting policy: revisiting draft and soliciting feedback soon, before taking it to Campus Assembly
 - d. Student organizations classification: We tabled this last semester but should take it up again.
