A. Proposed Poster Policy review

B. Student Organizations

Discussion of revised constitution from student organization - NASA -Native American Student Association. Viktor Berberi received some additional information from students, however the practice of two organizations seem very similar in missions. Sydney Loechler made a motion to table this approval until the student can attend a committee meeting to provide additional details. Bryan Nell seconded the motion. All members approved.

Students for Sustainability organization is requesting a name change to the Morris Treehuggers. Bryan Nell approved the name change with Kimberly Novotny seconding the motion. All members approved.

C. Student Organization approval and classification process

Committee members divided up peer and aspirational universities to review policies and report back at the next meeting for further discussion.
