1. Introductions, brief synopsis of powers of the committee.
2. The committee discussed academic policies as they relate to the First Year Experience (FYE), with Randy Swing, a nationally known consultant on the FYE.

How to attract and retain first year students:

- get students who are the right 'fit'
- use financial aid to attract them
- good academic advising
- first year seminar
  - must be consistent in work load between sections, but hard to do FYS that works for everyone is student body is dichotomous
  - decide on type – transition, thematic, discipline related or remedial

Academic Alert:

- for data analysis, separate NHS from freshmen by credit
- UMM doesn't have adequate faculty participation
- PB workshops need to be more intensive
- Use GPA as an outcome variable
- Intervene early first semester
- Data suggests we are successful at recognizing students in trouble, but outcome is same whether we recognize them or not
- Disaggregate data, different students groups are having very different experiences here academically

FYE:

- charge fee to support FYE (Ball St. charged \$1000.00/student)
- need more student affairs resources
- use students to tutor, co-teach, do academic advising

Marketing:

- market UMM as a grad prep school
- market how many student are residential and stay on weekends
- market how different from large universities
- make sure students get what we advertise, diversity and small classes
