- B. AFRC Annual Funding Request update by *Budget Manager Maloney (10 minutes)*

Maloney- Okay, so overall, I made a category that shows the requested budget changes. One thing is to increase sustainability forum funds. The second is to reallocate stipends to the PLS, and to request money for that. So we will be requesting an additional \$905 in funding.

Rosemark- This will hopefully be approved this coming Monday. The budget for this year is also linked. With this, we need to figure out how much carryforward we will have this year. Do we all feel like this is a good budget? There are lower positions that had stipends previously,

like \$25/semester, but we are cutting these. The reason we are is because at AFRC they said they were useless and too small, so they are pointless. Those positions are the senators, the sustainability officers, and the MSLC reps. The PLS part is built in so that the president and vice president can go to that.

Loechler- Have you looked into that being funded by catalyst?

Rosemark- Me and Josh did, but that was a one time thing. It's set up where MCSA/the school provides  $\frac{2}{3}$  of that, and the person supplies  $\frac{1}{3}$  of it, which goes along with the university's policy on travel funding. I think it would be good for us to vote on it to bring it to forum.

#### C. [President's Report to the Board of Regents](#) (5 minutes)
