- A. Tuition Waiver Info Session update by *Secretary Kornely (5 minutes)*

B. Privacy Concerns presented by *Secretary Happ* (5 minutes)

Happ- Mitch Scanlan came to me about an update to the advisor/success coach system. So, now notes from success coach/advisor meetings are public on the server for all of the University. These notes are made available to the entire system. So this brings up concerns about student privacy, especially because many people talk about mental health concerns with their success coaches or advisors, which many do not want to be made available. Jennifer Goodnough was not

very okay with it, and she would be able to help us get more information about it. And I don't know if it would be used to get that private information, but it could be. There's no way through the system to request access, it is just all open.

Happ- Jennifer was the one who showed Mitch the issue.

Rosemark- You should schedule a meeting with Brenda Boever and Jenn Goodnough.

Scovil- Is that the only switch the system made? Or was it a whole system wide change and that was a byproduct?

Westfield- That's so weird.

Rosemark- And all professors are advisors, so any professor could look into that.

Westfield- My advisor has never taken notes.

Happ- It could be an after the fact kind of thing. Yeah, so this is scary.
