- II. President's Remarks Discussion on Regent Sviggum's Comments

  Dylan: On Monday Oct 17th I sent Steve Svigum a letter responding to his comments at the mission fufillment meeting the following Thursday. In the letter I shared my experience as a Native student, invited Svigum to campus, and . Regent Svigum will be likely visiting on November 9th. I thank Svigum for having the character and humility to accept the invitation. I hope that after the visit he strengthens his commitment to diversity system wide. He has apologized and said he has a lot to learn about race and diversity. Recognizing that understandign diversity is a long and difficult journey. The exec committee discussed how we could help Svigum reach the understanding of diversity he wants and needs. One thing missing from these conversations is accountability; being held responsible for actions is the best way to learn. That is why we are sending a letter to ask Svigum to step down as the vice chair as the board. IN

this position one of his responsibilities is to support a; diverse student body. I believe that until he is further in his diversity journey he should not be in this role. I don't think facing consequences is negative or unconstructive, it's life. This does not contradict our original message. Anyone non forum members can share their thoughts and questions on the situation.

Ana: After hearing Svigums comments and hearing Dylan, it hurts more. As a student and person of color. When you're supposed of include diversity as a part of the regents mission. It causes an unwelcome feeling and it makes me feel upset and sad.

Robert: Since Svigum has doubled down multiple times, I feel like his apology was insincer and it feels responsible for him to step down at this point

Student: The board of regents is made of majority white older folks, and a lot of times they don't get consequences or feel them in these situations. I think that Svigum probably doesn't feel like he needs those consequences. I think it's good that we're asking him to resign from his position but not from the board.

Noelle: We also are not the first or only ones to call for Svigum to step down as vice chair, a regent called for this as well.

B. Resolution on Physical Campus Spaces Recognizing Indian Boarding School History and Current Day Native Students (<u>link</u>)

Description: This resolution proposes the creation of a campus assembly committee that would create a 5-year plan to renovate and create physical spaces on campus to recognize our history as an Indian boarding school and celebrate our current day Native American students. It also proposes updating the student center display case, a mural in the Turtle Mountain Cafe created by a Native artist, and the renovation of other physical spaces.

C. Resolution for Increased Reproductive Health Access (<u>link</u>)

Wade. It also proposes the installation of an emergency contraceptive vending machine in the 24 hour lounge.

Description: This resolution states that our student body is in favor of the University working to make agreements with Teamsters.

There was a plan for a strike starting October 24th due to unfair hiring practices, low wages, cutting hours, and removing health insurance from contracts. After 36 hours of mediation, the University agreed to their terms and this resolution says that we are in favor of that decision and urge the University to continue to provide for their employees instead of finding ways to cut labor costs.

Muthu: The questions could include the definition of microagressions in the questions where that's relevant

liz: does this relate to last years advocacy around paid sick leave

Dylan: Yes. One of the first things we did when making the survey was look at our goals of advocating for better working conditions and advocating for paid sick leave.

Robert: I feel like all the questions are good, but it is long. To condense it we could maybe combine similar questions and have check boxes. Like "Have you experienced microagressions, harassment, etc." could all be combined into one question.

Bonita: Does your employer offer and then list all the options

Adrienne: I'm curious is it mindful of students that have stipends, CAs, and students who don't have hourly wages.

Noelle: The only wage question is about if you make more than the minimum wage Jay: We can add in a stipend option. We can also have a question that asks does your stipend cover your cost of living.
