# Scholastic Committee Coordinator Responsibilities

## Description

The Scholastic Committee Coordinator serves as a Scholastic Committee (SC) representative to the campus community on a daily basis through the evaluation of delegated petitions, transfer evaluation, and ensuring compliance of SC policy and procedure.

## Petitions

Through comprehensive analysis of individual academic petitions and exercising independent discretion and professional judgment to make decisions, the SC coordinator manages several petitions that directly impact student retention and success. The SC coordinator exercises professional judgment to override University policy and procedures.

## Suspension and Probation

The SC Coordinator evaluates transcripts for suspension and probation and updates students' academic standing appropriately. The SC Coordinator communicates with students regarding their academic standing and explains policy and procedures for readmittance in the case of suspension. The SC Coordinator coordinates the review of applications for students looking to be readmitted after suspension and provides guidance and support to the Student Scholastic Standing Committee. The SC Coordinator also coordinates the review of suspension appeals for students wishing to return after being away for only one semester.

## Special Exams

The SC Coordinator helps organize special exams for language proficiency and discipline special exams to fulfill prerequisites for advanced courses.

## Meeting Administrative Support

The SC Coordinator provides accurate reporting of SC minutes and facilitates communication regarding meetings, minutes, agenda and relevant information among committee members.
