Dave emphasizes the two funding mechanisms: it is an "either-or" system, not an "and" system. ASG is more flexible, and the groups that are annually funded are locked in to their monetary allocation.

Dave notes that AFRC will rarely discuss fund allocation without a committee meeting – just in extreme cases.

“Health Services Fee” is now called “Health and Wellness Fee.”

We went over the structure of the binder.

There will be a training session in November for how to do Allocations. More info coming.

We will determine the hearing date for annual allocations at a later date.
