## **IV.** For Information: Student Health Insurance Update *Presented by Henry Fulda*

- a. [Handout] This subject addresses changes to the health insurance coverage for students. This requires students to be responsible for their healthcare.
- b. The new waiver process includes stricter standards that every student's insurance must meet, or they must sign up for the University-sponsored health plan. This hard waiver means that not only does a student have to do more to prove their insurance, they must have their insurance company send a certificate of proof of insurance for what the insurance covers. This will start during registration for fall of 2012 to meet the new University minimum standard of coverage.
- c. The University-provided health plan is a fairly good policy, for those whose insurance coverage does not meet the minimum standard of coverage. In the student coverage, there are few co-pays and no deductibles.
- d. Henry Fulda is still working on additional small revisions.
